

## Terms & Conditions - 20% Protection Bonus Promotion

For a limited time only, fund your The Liquidity (“we, our, us”) live trading account with a minimum deposit of **\$100** and become eligible for 20% Bonus of your original deposit as trading bonus (“**Liquidation Bonus**”). For every deposit you will be eligible for 20% Bonus, awarded at liquidation maximum bonus amount of 200 USD can be availed in one calendar month. At liquidation Bonus will appear as your ‘balance’ in your MT4 Platform.

Once Bonus is awarded to a trading account it can be withdrawn or used for trading.

### 1. How it works:

- 1.1. Firstly, you must ‘sign-up’ to the promotion by completing the online form (<https://direct.theliquidity.com/promo/tm20p>). Alternatively, you can request new account from your client portal by selection “20% Bonus” account plan.
- 1.2. Minimum Deposit at least \$100 (USD) into your new or existing trading account.
- 1.3. 20% Bonus of your deposited amount will be issued on liquidation.
- 1.4. 20% Bonus is capped at 200 USD for a given calendar month.
